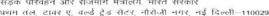

- 7. Eligibility Qualification: The basic eligibility for accepting Interns in NHIDCL will be as under:
 - a. Currently studying in the final year or pre-final year / semester of their course as certified by the concerned Head of Department/ Director/ Principal / Dean of the institute.
 - b. A student must have secured CGPA 7.0 (score of 70% shall be considered as equivalent to 7.0 CGPA) in the completed semesters and no backlogs (re-appears) of any subjects.
 - c. One student / candidate shall be allowed Internship only once in the NHIDCL.
- 8. The Intern should not be less than 18 years of age and not more than 30 years as on closing date of application.
- 9. **Submission of Application**: The interested students will have to apply online on **AICTE** https://internship.aicte-india.org/nhai.php. portal advertisement will be published on the AICTE & NHIDCL website for wider dissemination of Internship Program. Application received through any other mode would not be accepted and summarily rejected.
- 10. **Selection Criteria**: All applications received online will be forwarded to the Screening Committee in NHIDCL for further scrutiny and selection.
 - a. Depending upon the number of applications received against a particular domain/ area, NHIDCL reserves the right to fix-up the eligibility criteria, limit the numbers of applicants to be called for a particular period and to decide about the mode of screening thereof.
 - b. NHIDCL will shortlist the applicants and allot them to projects under ROs & HQ.
 - c. - d. Successful completion of the internship shall not automatically entitle the students to any kind of job in NHIDCL.
- 11. Logistics & Support: Interns will be required to have their own laptops. NHIDCL shall provide them working spaces, access, internet facility and other necessities as deemed fit by the concerned Heads. ROs / PMUs of NHIDCL shall arrange appropriate stay in the Contractor's Camp, if they are assigned to a particular work and transportation facility to the interns at site only.
- 12. Termination of Internship: Internship is a period of learning as well as teaching, therefore, it is expected that interns apply themselves seriously to the task assigned to them. Absenteeism, casualness and in-subordination will not be tolerated. It is expected that the interns will respect the ethos of NHIDCL at the place of their stay, be free of bias and bigotry in their work, their speech and written communication be sober and respectful at all times. Cases of indiscipline will make an intern liable for action, as decided by the Competent Authority.
